Lunar Sabbath Response Now Complete

The booklet "Lunar Sabbath Illusion" is now completed and uploaded on our Website, yrm.org. We have also finished half of the press run on the printed copies. We will distribute the printed copies either at the end of this month or early January 2010. This is one of our most extensive booklets yet. We think it scripturally defeats the major arguments of the false lunar Sabbath doctrine, a teaching that is gaining some momentum. Our next major publication will deal with the Easter celebration and its errors.

New Holy Day Calendar to Be Published Soon

A number of observers confirmed the new moon crescent Thursday night, 12-17-09, as projected on our calendar. We plan to have the 2010 calendar on our Website by the first of the year, ready if you need to set aside 2010 vacation time for the Feasts. A printed version is also forthcoming, which lists the projected times for the seven annual Feasts, the new moons and new moon sighting data on the reverse. Many are pleased to have this data in order to project better sighting locations and times in the western skies. If you are not familiar with watching for the new moon we invite you to get involved and contact us when you see it. The new moon marks the beginning of each month in the biblical calendar and sets the Feasts as well. It is found among the commands of Yahweh (Psalm 81:3), seen in the New Testament (Col. 2:16), and will be observed in the coming Kingdom Isaiah 66:23.

End-of-Year Taxes

A reminder that we will need any tithes and donations postmarked by December 31 if you want to use them for a 2009 tax credit. Some have questioned why we need tax exemption for the ministry. First, we get non-profit postal rates that are less than half of what we would pay without it. That amounts to thousands of dollars annually in savings. Second, we are allowed to purchase goods,

supplies and building materials for the Assembly without paying sales tax, which saves many hundreds of dollars each year. Third, it allows those who contribute to YRM the ability to save on their taxes each year. It does NOT mean that the government dictates what we do or teach. If it ever did, we would drop our tax-exempt status. Typically, those who criticize tax-exempt religious groups don't support anything financially anyway. And if everyone were to tithe we would never even need tax-exempt status.
